# Mission

---

The AMA Queensland Foundation's mission is to improve medical conditions in areas of need, by raising funds to finance and implement:

- ▶ improved or emergency medical services, especially in rural and remote areas;
- ▶ improved medical education; and
- ▶ vital medical research.

# Vision

In 2000, the AMA Queensland Council established a charitable foundation to provide additional alternative means for financing essential services, medical research and education.

AMA Queensland recognises there are times when extra help is needed to provide medical services and treatment to the disadvantaged. The AMA Queensland Foundation is an avenue to help such people.

The Foundation also places great value on the training of young doctors and medical research in Queensland and supports fellowships, financial assistance to medical students and research.

# Your Will

---

For many people, death is not something they like to think about, let alone discuss. Sadly, we all know that an accident or serious illness can occur at any time. A Will can make things easier for the people we love and care for. It ensures your family, dependants and loved ones are properly provided for and that assets are distributed according to your wishes.

## What is a bequest?

---

When preparing your Will and dividing your estate, your immediate family should be considered first. However for some people, giving through their estate is the only time they are able to provide a significant donation to an organisation they have respected throughout their lives.

## Making your Will

---

The choice is yours and you should speak with your solicitor about your options for making or updating your Will. Some of your options are outlined in this document.

The AMA Queensland Foundation hopes you will consider a Residuary Bequest. This type of bequest can give you the greatest peace of mind through allocating a residual of your estate after all your other gifts, taxes, and debts have been fulfilled.

This means you can look after your family first, and be assured the Foundation will benefit and your gift will make a positive impact on the lives of other families.

# More than 21 years of life-changing projects

---

With the help of AMA Queensland members, corporate sponsors and the public, the Foundation has contributed more than \$1.7 million to improve the health and wellbeing of many Queenslanders facing sickness, disability or financial hardship.



Here are some of the projects we have supported.

- ▶ A Fundus camera used by Dr Bill Glasson and others to conduct eye and diabetes screen clinics in West Queensland – 2003, 2004, 2005 and 2006.
- ▶ Since 2004, the AMA Queensland Foundation has provided more than \$475,000 in financial assistance to 28 medical students suffering financial hardship studying in Queensland.
- ▶ Donated \$10,000 to The VacSeen Project to cover the costs of running GP-led pop-up outreach health clinics for people experiencing homelessness and other disadvantage.

- ▶ Funding ENT surgical procedures for 36 remotely based Queensland children.
- ▶ In 2022, raised \$25,000 for Juiced TV to purchase a new broadcast camera to create positive experiences for sick children and their families at the Queensland Children's Hospital.
- ▶ Funding specialised tele-practice programs through Hear and Say for children living remotely requiring intensive speech therapy support.
- ▶ In late 2018, the AMA Queensland Foundation approached the Queensland Government to secure funding for the Hep C Kombi Clinic for three years. Queensland Health supported this application and committed \$231,000 in funding.



# Leaving a bequest in your Will

---

To make a bequest to the AMA Queensland Foundation in your Will, you can choose to give a portion of your estate, a set cash amount, real estate, shares, securities, life insurance, or other assets, such as fine art.

Once you have determined how you want to make a bequest to the Foundation, please consult your solicitor and request the inclusion of the following paragraph in your Will.

Please advise us if you wish your bequest to remain anonymous.

## Suggested legal wording:

***I give and bequeath free of all duties and taxes, (death, estate, succession or otherwise, payable in consequence of my death), (a portion of my Estate), OR, (a portion of the residue of my Estate) OR, (the sum of \$.....) OR, (a specific asset) to the AMA Queensland Foundation (ABN: 31 093 701 083) general purpose fund. To be applied for the general purpose of the Foundation. I declare that the receipt of the officer of the said Foundation shall be a full and sufficient discharge to my Trustee for the payment of the said sum, and that my Trustee shall not be bound to see the application thereof.***



# Storage and safekeeping of your Will

---

It is always advisable to keep the original copy of your Will in a secure place such as with your solicitor or trusted professional advisor. Make sure you retain a copy detailing the exact place of the original Will so that your executor will have easy access to it after your death. Your executor and at least one beneficiary should be informed as to its whereabouts or provided with a copy.

## Does your Will ever need changing or updating?

---

Wills should be reviewed as family and financial circumstances change, such as:

- ▶ marriage, separation, divorce
- ▶ births and deaths in the family
- ▶ major illness
- ▶ bankruptcy
- ▶ retirement
- ▶ your children entering into de facto relationships
- ▶ setting up your own practice.

You may feel the need, for instance, to change the guardianship arrangements you have made for your children or appointment of executors. A new Will is generally required to properly take such matters into account.
